- 3. The Earnest Money Deposit (EMD) of NRs. 30,000/- in the form of Account Payee Demand Draft/Pay Order drawn in favour of "Consulate General of India, Birgunj" is required to be submitted along with tender bids.

1. GENERAL INSTRUCTIONS

- 1.1 For the Bidding / Tender Document Purposes, the **Consulate General of India, Birgunj** shall be referred to as 'Client' and the Bidder/Successful Bidder shall be referred to 'Contractor and / or Bidder or interchangeably.
- 1.2 The tender document can be downloaded from the websites of http://www.eprocure.gov.in, www.cgibirgunj.gov.in from 14th February, 2025 onwards. The last date of submission of bids is 10th March, 2025.
- 1.3 While all efforts have been made to avoid errors in the drafting of the tender documents, the Bidder is advised to check the same carefully. No claim on account of any errors detected in the tender documents shall be entertained.
- 1.4 The bidder shall submit the copy of the authorization letter / Power of Attorney as the proof of authorization for signing on behalf of the Bidder.
- All Bidders are hereby explicitly informed that conditional offers or offers with deviations from the conditions of Contract, the bids not meeting the minimum eligibility criteria, Technical Bids not accompanied by EMD of requisite amount/format, or any other requirements, stipulated in the tender documents are liable to be rejected.
- 1.6 The Parties to the Contract/Agreement shall be the successful bidder (to whom the work has been awarded) and the Client, Consulate General of India, Birgunj.
- 1.7 For all purposes of the contract including arbitration thereunder, the address of the bidder mentioned in the bid shall be final unless the bidder notifies any change of address by a

separate letter handed over personally/courier or by email to the **Consulate General of India, Birgunj**. The bidder shall be solely responsible for the consequences of any omission or error to notify any change of address in the aforesaid manner.

1.8 The bidders are required to visit the site to assess the quantum of work involved before submitting the tender. Once the tender is submitted, it will be presumed that the bidder has seen and understood the complete work involved.

1.9 Terms & Conditions

 The bidder will have to ensure compliance of all mandatory Labour Laws/regulations laid down by the Government of Nepal and any other relevant acts and regulations enforceable from time to time without any liability on the Consulate General of India, Birgunj or without any responsibility for statutory compliance by the Consulate.

2. Scope of Work:

All work pertaining to proper maintenance of garden at the Consulate General of India, Birgunj. There are five lawns spread over an area of approximately 11,000 sq. ft.

Following will be the schedule of work:

- a. It is necessary to maintain the greenery and beauty of the garden situated at the premises of Chancery by planting suitable plants and seeds of good quality in the flower beds as per the seasons.
- b. The plants and trees of permanent nature planted at the Chancery premises should be well fertilized, pruned and cared properly.
- c. The grass lawns in the Chancery should be cared carefully. Unnecessary grass and plants should be weeded out and disposed off properly. The grass should be cut by lawn mower.
- d. The hedge around the grass lawns should be cut regularly to maintain a proper and neat shape.
- e. The Chancery premises should be decorated with 300 (three hundred) seasonal flower pots at different places as per the requirement. The pots available with the Chancery will be used for this purpose. The location of the flower pots can be changed as per the direction of the Chancery.
- f. The garden near the main gate of the Chancery should be made more attractive and additional attractive flowers and trees should be planted there.
- g. The agency is responsible to manage and provide the necessary qualified/professional manpower, flower and seeds of plants, mud, pots, fertilizer, agricultural tools and other necessary materials.
- h. All plants/trees should be watered daily or as required for keeping plants healthy. All uprooted/fallen leaves/trimmed part of plants should be disposed off properly on daily basis.
- Two Plastic sheds/Green House should be made as per the necessity for the protection of plants and trees.
- j. The provision should be made to sow and grow the seeds of seasonal flower in the plastic shed/Green House. The soil of garden should be ploughed properly.

- k. The unnecessary plants should be managed and uprooted timely and should be disposed off at designated place. The proper facility for the irrigation of garden and flower pots should be managed. Sprinkling of insecticides/pesticides should be done timely.
- l. Every morning in office day, flower bouquet should be decorated in the flower vase in the office of CG.
- m. The flower pots should be cleaned and colored in every 6 months.
- n. The agency should provide sufficient qualified/trained and experienced manpower to attend the daily requirement of garden work as well as additional work at the end of the season.
- o. The bids are being invited for providing gardening services at the Consulate General of India, Birgunj. Goods like pesticides, fertilizers, soil, manure, seeds and flowers will be provided by the Agency. The lawn mower and petrol for running it, will be provided by the Consulate.

The agency should provide **two (02) trained & experienced male gardeners** to work Monday to Saturday from 07:00 AM to 0330 PM (with 30 minutes lunch break) per day six days a week and one gardener would be on duty on Sunday and other local holidays for garden maintenenace.

3. MINIMUM ELIGIBILITY CRITERIA

- The Garden maintenance Agency should have been in existence for not less than three years.
- (ii) The agency should not have been blacklisted since inception.
- (iii) Due weightage may be given to the agency having its presence in multiple locations in Nepal.
- (iv) Nepali/Indian agency having garden maintenance work experience of not less than two years will be preferred.
- (v) Nepali/Indian garden maintenance agency should have proper registration with the concerned Government authorities.
- (vi) The agency should submit the following certificates at the time of submitting tender:
 - (a) Nepali/ Indian citizenship related certificate/documents
 - (b) PAN/VAT registration certificate

4. EARNEST MONEY DEPOSIT

- 4.1 The Earnest Money Deposit of NRs. 30,000/- in the form of account Payee Demand Draft/Pay Order issued by any reputed Bank drawn in favour of "Consulate General of India, Birgunj" has to be submitted along with the bid. The validity of the Demand Draft/Pay Order must be up to 6 (six) months from the last date for submission of bids.
- 4.2 No request for transfer of any previous deposit of Earnest Money Deposit or Performance Security Deposit or adjustment against any pending bill held by the Client in respect of any previous work shall be entertained.
- 4.3 Bidders shall not be permitted to withdraw their offer or modify the terms and conditions thereof. In case the bidder fails to observe and comply with the stipulations made herein or backs out after quoting the rates, the aforesaid bid security shall be forfeited to the government or will render the bidder ineligible to submit bids for contracts with the Consulate General of India, Birgunj.

- 4.4 The bids without Earnest Money Deposit will be summarily rejected.
- 4.5 No claim shall lie against the Client in respect of erosion in the value or interest on the amount of earnest money deposit or security deposit i.e. no interest will be payable on EMD.
- **4.6** The bid security may be forfeited:
 - (i) If the bidder withdraws his bid during the period of validity of the bids specified by the bidder in the bid form; or
 - (ii) In case of successful bidder, if the bidder:
 - (a) fails to sign the contract in accordance with the terms of the tender document;
 - (b) fails to furnish required Performance Security Deposit in accordance with the terms of Tender Documents within the time frame specified by the client; or
 - (c) Fails or refuses to honour his own quoted prices for the services or part thereof.

5. VALIDITY OF BIDS

- 5.1 Bids shall remain valid and open for acceptance for a period of 180 days from the last date of submission of Bids.
- 5.2 In case, client calls the bidder for negotiation then this shall not amount to cancellation or withdrawal of original offer which shall be binding on the bidder.
- 5.3 The client may request for extension for another period of 60 days, without any modifications and without giving any reasons thereof.
- 5.4 PRE-BID MEETING/SITE VISIT: Interested firms/service agencies may visit the site for visualization and better understanding of the quantum of work during 19th February, 2025 to 07th March, 2025 after fixing a prior appointment. A pre-bid meeting will take place on 19th February, 2025. The site address is Consulate General of India, Birgunj Shreepur, Birgunj, Parsa, Nepal. The bidders may also submit their queries by email on the aforementioned email IDs which will also be discussed in the pre-bid meeting.

6 PREPARATION OF BIDS

- 6.1 <u>Language</u>: Bids and all accompanying documents shall be in <u>English</u> only. The technical as well as the financial bids should be submitted in two sets one original and one copy.
- 6.2 <u>Technical Bid</u>: Technical Bid should be prepared as per the instructions given in the Tender Documents along with all required information, documents in support of the minimum eligibility criteria. All the documents comprising the Technical Bid shall be

put in a separate sealed envelope superscribed as "Envelope A – Technical Bid". Documents comprising the Bid:

- a. Technical Bid Submission Form duly signed and printed on Company's letterhead.
- b. Contact Details Form, duly filled and signed & stamped.
- c. All attested supporting documents in proof of having fully adhered to minimum eligibility criteria as referred in Section-3 above.
- 6.3 <u>Earnest Money Deposit</u>: Earnest Money Deposit of NRs. 30,000/- in the form of account payee Demand Draft or Pay Order to be submitted separately in a sealed envelope superscribed as "Envelope B Earnest Money Deposit".
- 6.4 <u>Financial Bid</u>: Bidder shall prepare the Financial Bid in the Price Schedule as provided in the Tender Document. Financial Bid shall be put in a separate sealed envelope superscribed as "Envelope C- Financial Bid".

7. SUBMISSION OF BIDS

7.1 The Bidding firms have to submit the tenders in two bid system i.e (i) Technical Bid and (ii) Financial Bid in the prescribed proforma. Tenders are to be submitted to Consulate General of India, Birgunj Shreepur, Birgunj, Parsa, Nepal. All the documents in support of eligibility criteria etc. and other required documents are to be submitted along with the Tender Documents. No Tender Documents will be accepted after the expiry of stipulated date and time for the purpose under any circumstances whatsoever.

.7.2 No Bid shall be accepted after the specified date and time. However, the Competent Authority in the Consulate General of India, Birgunj reserves the right to extend the date / time for submission of bids, before opening of the Technical Bids.

8. BID OPENING PROCEDURE

- 8.1 The **Technical Bids** (Envelope A) shall be opened at **Consulate General of India**, **Birgunj** in the presence of bidders or their representatives and the Tender Evaluation Committee constituted by the Competent Authority of the **Consulate General of India**, **Birgunj**. After evaluation of Technical Bids, a list of qualified bidders will be prepared by the **Consulate General of India**, **Birgunj**. The **Financial bids** (Envelope 'C') will be opened on a subsequent date, which will be intimated to the shortlisted bidders, by mail/phone.
- 8.2 Bids shall be declared as valid or Invalid based on the preliminary scrutiny, i.e. on site verification of documents submitted by the bidders by the Tender Evaluation Committee. The financial bids will be opened on result of such scrutiny. However, in case any thing found false or forged in contrary to the documents submitted by the bidder, its bid will be rejected and suitable legal action may be taken.

- 8.3 The Financial Bids of only those bidders, who qualify at Technical Bid stage, shall be opened by the Committee authorized for the purpose. Those bidders who qualify in the technical bid stage, will be intimated through mail/phone about the date for opening of the Financial Bids.
- 8.4 The date fixed for opening of bids, if subsequently declared as holiday by the Government, the revised date of schedule will be notified. However, in absence of such notification, the bids will be opened on next working date, the time remaining unaltered.
- 8.5 A letter of authorization shall be submitted by the Bidder's representatives before opening of the Bids.
- 8.6 Absence of bidder or their representative shall not impair the legality of the opening procedures.
- 8.7 After opening of the Technical Bids and verifying the EMD amount, the technical bids shall be evaluated to ensure that the bidder meets the minimum eligibility criteria as specified in the Tender Document.

9. CLARIFICATION ON TECHNICAL BID EVALUATION.

- 9.1 The Technical Bids shall be evaluated based on the available documents submitted by the bidder. To assist in the examination, evaluation, and comparison of the bids, and qualification of the bidders, the client may, at its discretion, ask any bidder for a clarification of its bid. Any clarification submitted by a bidder that is not in response to a request by the client shall not be considered. The client's request for clarification and the response shall be in writing.
- 9.2 If a bidder does not provide clarifications of its bid by the date and time set in the client's request for clarification, its bid may be rejected.
- 9.3 Client also reserves the right to seek confirmation/clarification from the issuer agency, on the supporting documents submitted by the bidder.

10. PERFORMANCE SECURITY (PS):

- The successful bidder has to deposit Performance Security which will be {5% of annual contract} in favour of 'Consulate General of India, Birgunj' in form of Demand Draft / Pay Order/Bank Guarantee within fifteen days of the acceptance of the Letter of Award (LoA). Performance Security should remain valid for a period of sixty (60) days beyond the date of completion of all contractual obligations of the service provider (SP). In case, the contract is further extended beyond the initial period, the Performance Security will have to be renewed accordingly by the SP. No interest shall be paid on Performance Security.
- 10.2 The Performance Security will be forfeited by order of the Competent Authority in Consulate General of India, Birgunj in the event of any breach or negligence or non-observance of any terms & conditions of the contract or for unsatisfactory performance or for non-acceptance of the work order. On expiry of the contract, portion of the Performance Security, as may be deemed fit by the Client sufficient to cover any

incorrect or excess payments made on the bills to the firm, shall be retained until the final audit report on the account of Contractor's bill has been received and examined.

- 10.3 If the Contractor fails to provide the Performance Security within fifteen days of the acceptance of LoA, such failure shall constitute a breach of the contract and the Client shall be free to make other arrangements at the risk, cost and expense of the Contractor.
- On due performance and completion of the contract in all respects, the Performance Security will be returned to the SP without any interest on presentation of an absolute 'No Demand Certificate' from the SP and upon return in good condition of any specifications, samples or other property belonging to the client, which may have been issued to the SP, for carrying out work stipulated in the contract.

11. VALIDITY OF CONTRACT

The contract, if awarded, shall be valid for a period of **ONE YEAR** (01 year). The contract may be extended annually on year to year basis, for further 02 years [maximum tenure 03 years from the date of start of work initially] as per the contract signed on same terms and conditions and same rates, subject to satisfactory services provided by the vendor. In case of breach of contract or in the event of not fulfilling the minimum requirements / statutory requirements, the client shall have the right at any time to terminate the contract forthwith in addition to forfeiting the performance security amount deposited by the Contractor and initiating administrative actions for blacklisting etc. solely at the discretion of the competent authority in **Consulate General of India, Birgunj**.

12. PAYMENTS

- 12.1 After award of work, a price schedule shall be annexed to the Articles of Agreement according to which all payments shall be made to the SP towards the AMC.
- 12.2 The prices in the Price Schedule shall be inclusive of all applicable taxes as may be levied by the Government from time to time.
- 12.3 All payments shall be made on **monthly basis** by means of crossed cheques/ bank transfer.
- 12.4 The Client shall be entitled to deduct in accordance with applicable law, Income Tax or withholding tax or other deductions (as the case may be), from any payments made to the Contractor, and the amount so deducted shall be deemed to be a payment made to the Contractor.
- 12.5 The payment to the gardeners in accordance to minimum wages prescribed by the local Government along with the statutory compliance Bonus is sole responsibility of the Contractor. In case of revision in minimum wages by the local Government, the same would be absorbed by the service provider. Claim for any escalation shall not be entertained by the Client.
- 12.6 No request for revision/ increase of approved rates during the currency of the contract will be entertained.

- 12.7 No payment shall be made in advance nor will any loan from any bank or financial institution be recommended on the basis of the order of award of work.
- 13. Other Conditions, Force Majeure & Penalty Clause
- 13.1 The gardeners so provided should be on the roll of the Company.
- 13.2 The bidder must have satisfactory arrangements for training of its workers. Confirmation in this regard is to be given.
- 13.3 The bidder should submit precise profile of its key clients along with details of services provided.
- 13.4 If any gardener is absent on a given day, the company will provide a substitute for him otherwise proportionate deductions will be made from the monthly payment.
- 13.5 In case the Service Provider fails in adhering to the daily garden maintenance requirements at Consulate General of India, Birgunj premises, and Client has to make alternative arrangements for daily garden maintenance, then Service Provider would be paid [minus] the cost incurred on purchase of garden maintenance related materials.
- 13.6 Contractor would be fully responsible for all acts of omission or negligence, dishonesty or misconduct of its employees for work at **Consulate's** premises. Contractor would indemnify Client against any compensation/claim and damages etc. due to accident or injury to its employees or death due to accident or otherwise, which may arise out of and during the course of their duties. Client would not be liable to pay any damages or compensation to such gardeners or to any third party.
- 13.7 In case of any complaint, either as regards the nature of service or as regards the behaviors of gardeners on duty or otherwise, Contractor would be intimated and would be required to take corrective measures promptly.
- 13.8 Client reserves the right to amend/withdraw any of the terms and conditions in the tender documents or to reject any or all tenders without giving any notice or assigning any reason. The decision of the Client in this regard shall be final and binding on all.
- 13.9 Client reserves its right to revoke the contract at any time, if the services rendered are not found satisfactory during the period of the contract.
- 13.10 Client may, by written notice sent to Garden maintenance agency, terminate the contract, with a notice period of at least one month, in whole or in part at any time for its convenience. The notice of termination shall specify that termination is for the Client's convenience, the extent to which performance of work under the contract is terminated and the date upon which such termination becomes effective.
- 13.11 The bidder must have modern equipment(s), latest technical expertise for management of garden, as has been defined in brief scope of work. Machinery, equipment, implements, items including pesticides, fertilizer, soil manure, seeds and flowers

proposed to be used should be clearly indicated. List of equipment owned by the company may also be furnished with the bid.

- 13.12 Any wrong or misleading information will lead to disqualification.
- 13.13 The bidder shall maintain at all times machinery / equipment and other resources required for **upkeep and maintenance of garden lawns** of the premises of the Client. The SP will arrange at his own cost additional machinery/ equipment and resources if required by the Client for the purpose.
- 13.14 Client reserves the right to remove any person found unfit.
- 13.15 The bidder would be responsible for all mandatory compliance for social, safety and environmental issues related to the performance of the service provider in the Mission's/Post's premises as stated in the eligibility criteria.
